HOW TO MAKE A PAYMENT:

- A) Online with Credit/Debit: Visit www.citrusmedical.ca/make-a-payment
- B) eTransfer to info@citrusmedical.ca. It will be an automatic deposit to "1919145 Ontario Inc". Please include the name of the patient and the item you are paying for in the message.
- C) Phone with Credit/Debit: call 416-800-6500
- D) In-Person with Credit/Debit or Cash **exact change only*

ANNUAL BLOCK FEE TERMS AND CONDITIONS:

1. The exact fee for forms is up to physician discretion and is determined based on the complexity and requirements of the form.
2. Block fee plans will start the day payment is received. The block fee can be paid on the same day as any payment for uninsured services to cover that service.
3. The block fee covers the following 12 months of services exclusive *i.e. payment Jun 1, 2025 will result in last coverage day being May 31, 2026*
4. Individuals covered by the couple or family plans must all be living at the same address.
5. After payment is received, you will have one week (7 days) to make any changes including cancellation with full refund, converting to a different plan, or adding family members. Any services covered during that time will be required to be paid before receiving the refund.

Frequently Asked Questions About the Block Fee:

1. Is the annual block fee mandatory?
 - a. No. The block fee is optional. You can still have access to all uninsured services at Citrus Medical and continue paying per service. There will be no difference in the service provided whether paid through the block fee or per service.
2. Is the block fee refundable?
 - a. After payment is received, you will have one week (7 days) to make any changes including cancellation with full refund, converting to a different plan, or adding family members. Any services covered during that time will be required to be paid before receiving the refund.
3. When does coverage begin and end?
 - a. Coverage begins on the date payment is received and lasts for 12 months. For example, if payment is received June 1, 2025, coverage will last from June 1, 2025 to May 31, 2026 inclusive.
4. What if my family members live at different addresses?
 - a. Please contact the clinic at 416-800-6500 or through our website contact form.
5. What if I have more than 5 people in my family?
 - a. Adding family members will be \$30.00 per additional member.
6. Do all doctors at Citrus Medical participate in the block fee program?
 - a. All family doctors and urgent care doctors will have this program available. Specialists including allergists, hematologists, or hypertension specialists, do not have the annual block fee option.
7. Is the block fee covered by private insurance plans?
 - a. Some private insurance plans may cover block fees as part of the healthcare coverage, but it's crucial to check with your specific insurance provider.
8. Are doctors allowed to charge patients for services?
 - a. Yes. Not all services provided by doctors in Ontario are insured services covered under the Ontario Health Insurance Plan (OHIP).
